The distance to the airport is 30 minutes, the nearest shopping facilities are 5 minutes away. In San Antonio you will find a large

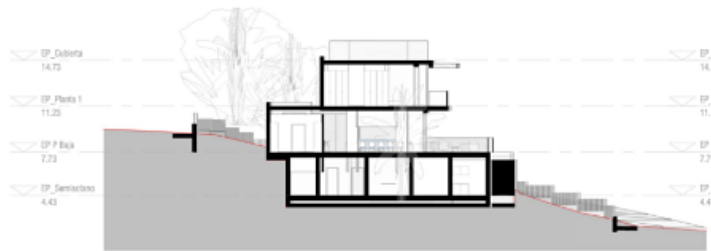
selection of restaurants, bars and club entertainment. The popular Cala Salada beach is only a 10-minute walk away.



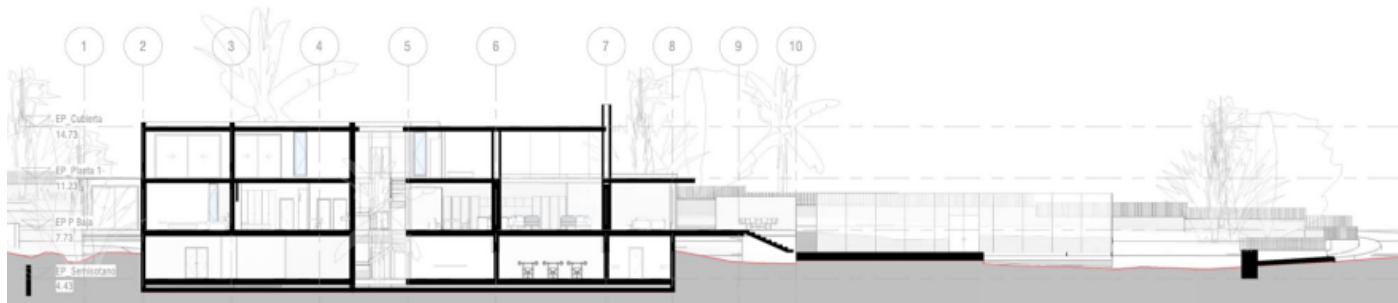

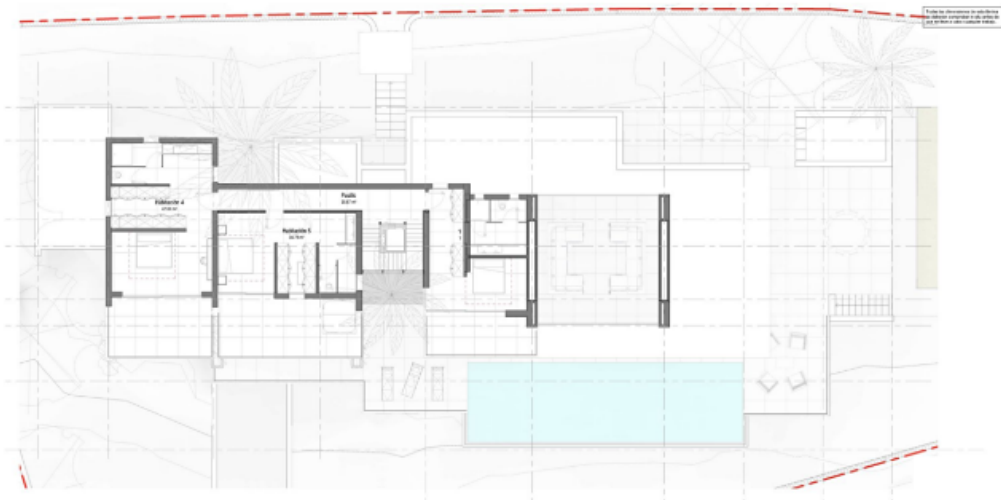

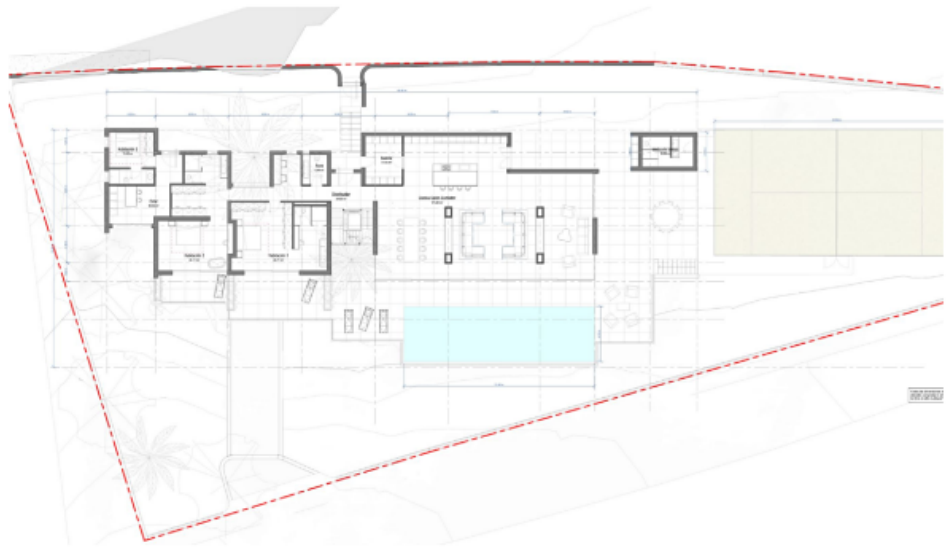
